

## Authors of the volume

*Tünde Fűrész* is the President of the Mária Kopp Institute for Demography and Families. She is an economist with law specialisation, as well as being married and mother of three daughters. Since 2010, she has been active in shaping Hungarian family policy, first as the Head of Department responsible for the policy field and then as the Deputy Secretary State responsible for Family Policy and Demography. As a Ministerial Commissioner, she was responsible for the transformation of the Hungarian crèche system. Since 2018, she has been the President of the Mária Kopp Institute for Demography and Families. Tünde Fűrész was awarded the Teréz Brunszvik award in 2018, in 2021 she received the Knight's Cross of the Hungarian Order of Merit in recognition of her professional work in the interests of families.
